#### Dewey's Run Nature Trail Revitalization By Madison Young

Did you know there are several walking trails around our community? Twisting and turning through our beautiful neighborhood, these trails weave throughout a serene, lush landscape. Dewey's Run Nature Trail is one of these trails, and is located right off the cul-de-sac at the end of Dewey's Run Lane and has recently been revitalized for your outdoor pleasure. Look for the flowers and wooden steps that lead down to the path right off of the curb. About half a mile long, one-way, the path is sur-



rounded by lush trees and bushes. You'll see wildflowers in the late spring and blackberry bushes in the summer. There is also a segway to the beautiful Dewey's Creek. This is a great place to get your feet wet and look for signs of wildlife. Trail markers, a bench for resting, and a trashcan have been added to keep this trail enjoyable and easily maintainable for years to come. From the Desk of the General Manager...

During my years of working in the Property Management field I have found it helpful, to Homeowners and Residents, to include a part of the Governing Documents in the newsletter. The following are excerpts from the Community's Architectural Guidelines which may help in complying with the Covenants of the Southbridge Community Association.

#### <u>Parking in Visitor Parking</u> Spaces

The Association has received numerous complaints concerning vehicles



parked in the visitor parking spaces in the townhome sections. Each property is only allowed two (2) assigned parking spaces. The Reserved Parking

Space Assignment Plan clearly states, " Visitor parking spaces are designated for visitor parking ONLY." Households with more than two (2) vehicles are to park their extra household vehicles off the property or in overflow areas within the property. Continuous violation will result in the towing of your vehicle. If you are having visitors, a visitor pass will be issued by the association office during normal business hours. You must provide the make, model, and plate number of the vehicle. A parking pass will be issued for a period not to exceed seven (7) days. If visitors come after the association office has closed, please contact the community patrol at (703) 880-6360 and they will issue a temporary visitor pass valid for that date only. You will be advised to contact the association office at (703) 221-7716 during working hours to be issued a current visitor pass. Please contact the office at the number referenced above if you have any questions or need additional information.

All motor vehicles including, but not limited to, trail bikes, motorcycles, dune buggies, and snowmobiles shall be driven only upon paved streets and parking lots.



No motor vehicles shall be driven on pathways or unpaved portions of Common Area, except such vehicles as are authorized by the Board of Directors as needed to maintain, repair, or improve the Common Area.

Non compliance of any item listed may result in a Hearing before the Covenant's Committee where assessments may be applied. Thank you for your un-



derstanding that all Association members are subject to the same rules and restrictions as defined in the governing peed further assis-

documents. If you need further assistance with any item mentioned, please feel free to contact the Association Office for additional information.





## The Park Authority Reminds You To Play It Safe

As the summer season of fun and frolic approaches the Prince William County Park Authority reminds everyone to play it safe in and around the water. Follow these simple rules of water safety every day:

- Always swim with a buddy in lifeguard-supervised areas.
- NEVER swim alone!
- Be cool & follow the rules of the pool.
- Never dive in shallow water. Look before leaping!
- Walk, don't run around swimming areas.
- Know how deep the water is where you will be swimming.
- Don't swallow the pool water. (YUK)
- Take a break, use the restroom.
- If you need help, alert a Lifeguard.
- Use only Coast Guard approved life jackets; not inflatables (water wings).
- Do not push, shove, or run near the water. Horseplay can be dangerous.
- Never swim around or under diving boards or slides.

## Prince William County Zero Tolerance for Illegal Fireworks

During June, Fireworks Safety Month, and continuing through the latter part of July (June 22<sup>nd</sup> – July 22<sup>nd</sup>), fireworks-related injuries peak; it's during this brief period, 67 percent of fireworks-related injuries occur. In 2009, according to Consumer Product Safety Commission, emergency departments treated an estimated 8,800 fireworks-related injuries; an increase of 26 percent from the previous year's 7,000 injuries. Children under the age of 15 accounted for 39 percent of fireworks-related injuries while children and young adults under the age of 20 comprised the largest number of fireworks-related injuries (54 percent) during this time period.

In an attempt to reduce the number of fireworks-related injuries and deaths, public information and public education are vital to the community. The Fire Marshal's Office, a division within the Prince William County Department of Fire and Rescue, has initiated a Fireworks Enforcement Campaign to stop possession and use of illegal fireworks. The campaign's slogan, *Illegal Fireworks, "If You Light It, We'll Write It!" Leave Fireworks to the Professionals* is a means by which the Department is able to educate the community about the dangers of illegal fireworks while informing them about Prince William's zero tolerance for possession and use of illegal fireworks. This year as in the past, Fire Marshals will be teaming up with Police for their annual fireworks safety initiative and deploying personnel throughout the County in an effort to prevent injury and fires due to illegal or unsafe use of fireworks. In addition, the team will write summons to individuals who possess and/or light illegal fireworks and will confiscate any and all illegal fireworks found in their possession. In Prince William County, the discharge of illegal fireworks is a Class 1 misdemeanor punishable by fines up to \$2,500.00 and or up to one year in jail.

Safety experts agree that the best way to protect your loved-ones from fireworks-related injuries or worse is to <u>not use fireworks</u>. Numerous professional organizations often provide fireworks displays for public enjoyment during the holiday and throughout the year. Check your local newspaper or web site for listings of fireworks displays in your area.

Should you choose to use legal fireworks, the Fire Marshal's Office would like to help you celebrate safely by suggesting the following safety tips:

- Fireworks should only be used under adult supervision.
- Fireworks should only be used outdoors on a driveway, sidewalk or other fire-resistant surface. Remember, fires are caused by careless handling of fireworks in areas exposed to sparks or live fireworks.
- Never ignite fireworks during high winds where flying sparks can start a fire.
- Keep a bucket of water handy in case sparks start a fire.
- Be sure children around fireworks know to stop, drop and roll if their clothing catches on fire.
- Deposit sparklers in a metal container as they may be stepped on while hot or lost in the grass and stepped on while playing.
- Never aim or throw fireworks at another person.
- Never try to re-ignite fireworks that malfunction or fail to go off.
- Do not wear loose clothing when using fireworks.

• Never experiment or make your own fireworks.

Never carry fireworks in your pocket.

## Stay Safe by Staying Cool - Know the Signs/Symptoms of Heat Stroke

As periods of high temperatures continue throughout the summer, individuals should heed weather warnings to avoid becoming a victim of hyperthermia, a heat-related illness referred to as heat stroke/sunstroke. Hyperthermia occurs when the body is exposed to excessive heat and produces or absorbs more heat than it can release causing the body's temperature to climb.

Hyperthermia can affect anyone, yet children and the elderly are most vulnerable. Each year, children die from hyperthermia after being left unattended in motor vehicles. In 2010, there were a total of 49 hyperthermia deaths of children left in cars. So far this year, 6 children have died in hot cars due to hyperthermia. As July approaches, the most deadly month for children trapped in cars, safety advocates Kids and Cars and Safe Kids USA remind parents and caregivers to be vigilant and take time, today, to begin implementing and practicing safe measures in the prevention of injuries and deaths caused by vehicular hyperthermia. To prevent this tragedy from occurring parents and caregivers must:

**<u>NEVER</u>** leave children unattended in a car - NOT EVEN FOR A MINUTE

ALWAYS check the back seat of the vehicle before exiting (Beat the Heat,

Check the Backseat)

Symptoms of hyperthermia are:

- Heat Stress (strain placed on the body as a result of hot weather)
- Heat Fatigue
- Heat Syncope (sudden dizziness)
- Heat Cramps
- Heat Exhaustion
- Heat Stroke

The two most common symptoms of hyperthermia are heat exhaustion and heat stroke. Heat stroke is the most dangerous symptom. When heat stroke occurs, individuals should seek immediate medical attention. Signs/symptoms of heat stroke are:

- High body temperature (above 103°F)
- Red, hot, dry skin (no sweating)
- Rapid, strong pulse
- Throbbing headache
- Dizziness
- Nausea

According to the Center for Disease Control (CDC), the elderly are vulnerable to heat-related illnesses as heat stress due to underlying medical conditions, lack of air conditioning, social isolation and poor economic status. To protect the elderly:

- Visit them at least twice a day; watch for signs of heat exhaustion or heat stroke
- Take them to air-conditioned locations
- Make sure they have access to an electric fan (continued on page 18)


